

## Key things to do if you are facing foreclosure:

1. Get Support. There are counseling agencies to help you deal with the financial aspect of foreclosure. They can explain your options and sometimes advocate on your behalf. Use a HUD Approved counseling agency.
2. Avoid Scams. Do not pay anyone upfront money to stop or eliminate a foreclosure. Many people promising to do so are scam artists. They cannot guarantee what they promise and you will lose money.
3. Be persistent. Open all the mail you receive from the bank or servicer. Call them weekly until you reach the loss mitigation department. Don't give up.
