Mr. Bell responded that was correct, and, in this instance, to the best of his knowledge all surrounding parcels had adequate access.

- 6. The Jersey wall barriers at the intersection of West Street and Cartier Avenue must be removed prior to recordation of the vacation.

<u>Item No. 7-2:</u>

D. Taylor, 1630 South Commerce Street, Las Vegas, Nevada Director for the Culinary Workers Union, stated the union did not represent any of the workers at the Fiesta Hotel and Casino but was concerned with the impending termination of approximately 1,000 workers when Station Casinos took over operations. Mr. Taylor stated approximately 130 of those workers resided in North Las Vegas. He pointed out Station Casinos recently purchased The Reserve in Henderson as well as an unnamed project in Missouri and did not terminate those work forces. He urged Council to discover the reason why the work force would be terminated before approving Station Casino's business license.

Mayor Pro Tempore Robinson asked Mr. Taylor what reason was given to the employees for the termination. Mr. Taylor stated that was best answered by Station Casinos representatives and that at one point, they stated they had to 'Stationize' their property.

Mayor Montandon commented it would be interesting to determine where Station Casino's would get a new work force to replace the existing workers.

Councilwoman Smith questioned the disparity in the termination practices of Station Casinos. She asked City Attorney Sean McGowan if it was appropriate to ask those questions of Station Casinos before granting the business license. City Attorney McGowan stated the application was for a privileged liquor and gaming license and Council had the authority to deny such licenses for any reason deemed reasonable. It was Council's discretion to determine if the applicant was not a proper person to be entrusted with the privilege of operating the business under the terms of the license, or if the application contained fraudulent representations. Mr. McGowan stated in fairness, it would be appropriate to allow the applicant to speak to the same issues brought up during this discussion and that it would be appropriate to table the issue until such time as a representative from Station Casinos could appear before Council. A special meeting could be arranged if necessary.
