#### **BUSINESS**

19. PRESENTATION BY DOUG DICKERSON ON THE NEVADA LEAGUE OF CITIES AND MUNICIPALITIES GOALS AND SERVICES.

Doug Dickerson, President of the Nevada League of Cities and Municipalities, stated the League office was in Carson City, close to the Legislature. The location of the office was

convenient for the League with regard to their lobbying efforts. The executive board requested Mr. Dickerson spend approximately one half his time in Southern Nevada. It was hoped a second office would be opening soon in the Las Vegas Valley. After the next election, Mr. Dickerson pointed out, 45 of the 63 legislators would live in Clark County. The presence of the League in Southern Nevada was thought to be an important consideration.

Mr. Dickerson felt the best way to provide services was to improve communication between the League office and member cities. The computers and software have been upgraded and the website was in the process of being enhanced. The goal was to create more information for members to make the website a more valuable asset. Resources centers would be created on the website as well as legal case references.

Mr. Dickerson stated a major goal of the League was to coordinate legislative activities. The League was working with the Government Affairs Subcommittee to develop software to track all bills of interest to member cities. An intern would be working with the League to input all legislative information into a database for review by member cities. It was hoped through that information, the League could also obtain the member cities' positions on certain bills for lobbying efforts.

Mr. Dickerson stated he wanted disagreements between cities to be resolved prior to presentation to the Legislature. There were 24 League members; those members represented 1.25 million citizens. The cities were the first line of service to the residents and if the lines of communication could involve them, the League would be a much stronger force when dealing with the Legislature.

Mr. Dickerson stated the annual conference would be in Minden/Gardnerville at the Carson Valley Inn, August 8 - 10, 2002. Informational and motivational programs will be offered for all participants. Mike Fortino, a noted motivational speaker would be speaking and moderating several discussion panels. Robert Guyer, a published author, would speak regarding methods for lobbying State Legislature.

Mr. Dickerson summarized by stating the League was established to assist the cities in meeting their goals. Limited research services were available.

Mayor Montandon commented the City had a policy whereby a legislative platform was developed before Legislature began. It was hoped the City could work with the League to develop the next legislative platform. Mr. Dickerson agreed.

# 20. PRESENTATION OF A REPORT ON THE FINDINGS REGARDING THE I-15 NORTHEAST CORRIDOR STUDY BY THE NEVADA DEPARTMENT OF TRANSPORTATION AND APPROVAL OF THE STUDY RECOMMENDATIONS.

Public Works Director Jim Bell stated the corridor study was prompted by a request from the City to study the transportation needs in the northern portion of the valley. It was necessary to carefully plan the roadways as the population in the valley was doubling every ten years. The study was similar to one prepared for the I-95 corridor and would focus on recommended future projects.

Myra McKissick-Brown, Nevada Department of Transportation (NDOT) stated in September 2001, NDOT hired Mr. Roger Patton from the Louis Berger Group as a consultant to prepare a study of the northeast region of the valley with regard to transportation needs for the area east of Martin Luther King Boulevard. Public information meetings were held several times and from those meetings, recommendations were proposed for the widening of I-15, enhanced transit improvements, arterial and road collector improvements and the study of an eastern beltway.

**Roger Patton, Louis Berger Group** stated the attempt was to create a plan to correspond with the anticipated build out of the northern portion of North Las Vegas as well as unincorporated portions of Clark County in the north east region. The report was in draft form and it contained three major recommendations divided into three elements: widening of I-15, arterial street improvements, and transit improvements.

Mr. Patton stated the widening of I-15 was the major recommendation because it provided the most benefit in the northern portion of the valley. The proposal consisted of a recommendation to widen I-15 to ten lanes from the Spaghetti Bowl north to Lake Mead Boulevard, eight lanes north to the northern beltway, and six lanes north as far as the speedway. As part of the I-15/Northeast corridor improvements, NDOT was also proposing the Lake Mead Boulevard interchange be completely reconstructed to allow for six lanes through to Lake Mead Boulevard and a reconstruction of the ramps to handle the higher volumes of anticipated traffic. As an early action item, NDOT was moving forward immediately with improvements to the Craig Road Interchange at I-15.

Mr. Patton stated there were approximately 50 additional arterial street improvement projects in addition to the improvements identified in the current Regional Transportation Plan. These improvements were intended to complete an arterial street network to serve future development on Craig Road as far north as Grand Teton. The shortage of north/south streets connecting in from the northern part of the valley into North Las Vegas was also recognized. Substantial improvements were proposed including widening and improving North 5<sup>th</sup> Street to extend continuously from Las Vegas Boulevard North to the

northern end of the valley. Another recommendation was to make a connection between Losee Road and Civic Center Drive north of Cheyenne which would then make Civic Center and Losee Road a continuous north/south roadway to supplement Lamb Boulevard and Martin Luther King Boulevard and add four north/south streets. That would substantially improve the flow of north/south traffic, reduce the amount of traffic using the interchanges, and generally provide a great deal of congestion relief throughout the northern part of the valley.

Mr. Patton stated the third part of the proposal related to transit enhancements. The proposal included using the express lanes currently proposed by the Regional Transportation Commission on Las Vegas Boulevard, extending that route as far north as the speedway and south into the downtown area of Las Vegas and taking what would be the future fifth and sixth lanes on North 5<sup>th</sup> Street and converting them to bus rapid transits with express bus routes. The same situation was proposed for East Lake Mead Boulevard. This would create a system of express routes with rapid transit going in three directions and coming together in downtown North Las Vegas. An intermodal transportation hub, similar to the existing hub in the downtown transportation hub in Las Vegas, was proposed for North Las Vegas.

Mr. Patton stated the recommendation held a price tag of approximately \$700 million, split evenly between the three elements. Many of the arterial street improvements would be funded by private developer contributions. Transit would partly be paid for by fare box recovery.

Mr. Patton stated as part of the project, Clark County requested a preliminary evaluation of an eastern beltway. The study identified a substantial transportation benefit associated with having a beltway that traversed the entire eastern portion of the valley. The study also indicated there would be very large impacts associated with the proposal as well. It was expected there would be at least 750 or more homes in need of relocation. The cost would be approximately \$900 million to construct the 17-mile section of beltway. In that area, the properties purchased would be more costly because they were developed. It was the recommendation of NDOT that further studies were required to identify if the impacts could be mitigated. If the project were to go further, it would most likely be a Clark County project.

Mayor Montandon asked if approval by Council would create one aspect of a capital improvement plan. Director Bell responded it would be included in the ten-year plan or the Statewide Transportation Plan. There were many possibilities for funding projects. Mayor Montandon stated one aspect of the arterial street widening project would be developer contributions which would be planned in advance. Portions of the transit system that would not be funded by fare box recovery, the I-15 and arterial streets widening, and the eastern beltway if approved would generally be covered by RTC3 funds. Director Bell stated RTC3

completed a study that indicated normal road improvements were necessary but increased public transportation needed to be addressed as well. It was the goal of NDOT to meet their goals by matching these projects with typical roadway improvements. Director Bell pointed out tentative projects had already been submitted to RTC3.

Debt Management Commission

as part of the on-going school construction project. Mayor Montandon stated this was a one-year bond which meant spending during the coming year would be approximately \$40 million per month. The School District was focusing on constructing high schools with this wave of funding.
