Mayor Montandon opened the Public Hearing.

Development Services Director Kristaponis explained the application for a use permit was located in the existing retail center at the corner of Craig Road and Simmons Street. The

City's ordinance required a special use permit for financial institutions. The special use permit was heard before the Planning Commission. Staff had recommended the item for approval. In determining the granting of a special use permit, there were four specific items that were required to be considered by both the Planning Commission and City Council:

- 1. The proposed use at a certain location was necessary and desirable to provide a service or a facility which would contribute to the general well being of the area.
- 2. The use would not, under the circumstances of the particular case, be detrimental to the health, safety or general welfare of persons residing or working in the vicinity.
- 3. The proposed use complied with the regulations and conditions of the City's code.
- 4. Should the special use permit be granted, the Master Plan would not be compromised.

Director Kristaponis stated in considering the case, the Planning Commission determined that Finding No. 1 was not met. Within a mile radius of the proposed location, there were two existing establishments offering that type of use. Because of that, the Planning Commission felt having a third such use in close proximity was not desirable and therefore, felt only three of the four findings were met. Under current City ordinance, all findings must be met before the application could be recommended for approval. The item was unanimously recommended for denial.

Mayor Montandon questioned whether Staff recommended approval of the item. Director Kristaponis clarified the Planning Commission recommended denial and Staff had recommended approval.

Joe Brown, member of the Jones, Vargas Law Firm, 3773 Howard Hughes Parkway, Las Vegas, represented the applicant and introduced Carol Stewart, Vice President for Government Affairs, and Adrienne White, Director of External Affairs, both from Advance America. Mr. Brown was grateful for the opportunity to clarify the reason why Finding No. 1 was not met by the Planning Commission. He felt it was a mis-apprehension regarding the types of the uses the establishment offered to its clients. Mr. Brown pointed out Advance America's business was distinguishable from the other two locations in the proximity of the proposed establishment.

Councilman Buck requested the hours of operation. Ms. White responded the hours would be from 10:00 a.m. to 5:00 p.m. and 10:00 a.m. to 3:00 p.m. on Saturdays. The business would be closed Sundays and evenings.

Councilwoman Smith questioned the rates established for this business and other similar businesses in the area. Ms. White stated they had contacted approximately 15 pawn shops and check cashing businesses in the area and had responses from 13 of them. The median fee was \$20. The range was \$15 to \$30 per \$100 borrowed. Mr. Brown stated

Advance America's fee was \$17 per \$100 borrowed.
