Acting Planning and Zoning Director Frank Fiori explained this ordinance was previously before Council, originally presented in April, 2008 and approved with amendments making the use of the additionally proposed security measures applicable only to industrial zones and not commercial zones. It was brought back in the original configuration and the attached proposed new ordinance repealed Ordinance No. 2439 as approved by Council and contained the original language which included reference to commercial districts. Under this proposed ordinance the amendment would allow an individual to request additional security measures through consideration of a Special Use Permit. Those additional security measures would include but were not limited to razor wire, barbed wire and electrical fencing. It would be reviewed on an individual basis through Special Use Permits for Council approval.

Councilwoman Smith explained she was opposed to placement of barbed wire in commercial zoning especially if it was not visible to the public and felt other options should be used before barbed wire was installed.

Mayor Montandon explained that the ordinance needed to be adopted to be able to consider properties on an individual basis. Councilwoman Smith explained it appeared to currently affect one commercial business.

Councilwoman Buck explained that applicants should be considered on a case by case basis.

Mayor Pro Tempore Robinson questioned the liability. City Attorney Carie Torrence explained that if Council approved barbed or razor wire that was visible to the public, there was no liability concern. She explained she was questioned whether the razor wire could be installed in the ground underneath the wall so that if someone jumped over the wall they would land in the razor wire. City Attorney Torrence felt that could be a legal liability that could come back on the City. It was also explained there were two issues, whether it was visible or not visible. City Attorney Torrence explained that voting no meant razor wire and barbed wire would not be permitted in commercial zones.

Louis DiFrancesco, 4460 North Decatur Boulevard, North Las Vegas, owner of Store More, explained that the impression received was that the razor wire would be a possibility. He explained there was an issue with people jumping the wall and the business had 29 break-ins over a two year period. He requested help with stopping the problem. Mayor Pro Tempore Robinson questioned whether there were dogs on the site. Mr. DiFrancesco explained they could not have dogs because there were people coming and going in the early morning hours. Mayor Pro Tempore Robinson was concerned with children in the area that may fall onto the wire horsing around and felt there should be other options researched.
